APPROVAL OF MINUTES

Matt Heins moved to approve the minutes from the June 9, 2015 board meeting. Don Hatler seconded. Motion approved unanimously.

Clallam County Dept. of Community Development (CCDCD) partnership discussion

Joe Holtrop discussed District programs that complement CCDCD activities such as onsite septic repair (OSS) cost sharing and the Pollution Identification & Correction (PIC) plan that will begin later this summer. Joe explained that the District has grant funds available for cost sharing on the repair or replacement of failing septic systems, and described how referrals must come from the County Environmental Health Department, which makes the homeowner financial need determination.

Rivers End Failing Septic Repair Assistance Request

Joe described the Rivers End area where the Jamestown S'Klallam Tribe, County, and State have been trying to buy out homeowners because the area is prone to flooding and septic systems are below flood level. A homeowner in the Rivers End area with a failing septic system has inquired about septic repair financial assistance. The Board decided to table the issue until the full Board can discuss, but the consensus of those present was a reluctance to fund a project that could wash away in the next flood.

REPORTS

Staff Reports

Jennifer Bond reported the FFA project is on track for finishing the project by this fall. Jen also reported on the public meeting that will be held in August to discuss the PIC pilot project in the lower Dungeness area. Streamkeepers has already begun trends monitoring. The Tribe is waiting until after the rains begin to start targeted sampling; however, shoreline monitoring may begin this summer. Joe Holtrop updated the Board on the Jakeway/Carlsborg Road Aquifer Project – C&J Excavating was the low bidder and the project should be completed by the fall. Joe also reported that we are in the final stages of designing the Dungeness Irrigation District piping project from Hendrickson Road to the McComb Road area. Joe has been asked to apply for a position on the Puget Sound Partnership Shellfish Strategic Initiative Transition Team. The Transition Team plans to meet in Olympia 8 – 14 times over the next 6 months and will solicit, review, evaluate and recommend

content for the 2016/17 Puget Sound Action Agenda update. All Transition Team participating expenses are eligible for reimbursement, including time and travel. Since this will take time away from his normal duties, Joe asked for the Board's input on whether he should apply. The consensus of the Board was that it would be worthwhile for him to participate.

More activities for the month can be found in the attached Conservation District Staff Report.

NRCS Report

Jim Poffel was unable to attend, but submitted a written report (attached).

Treasurer's Report

Matt Heins moved to approve the June 2015 Treasurer's report and approve for payment electronic funds transfers and checks described as FF 8852-8891 and SCB 235 dated June 1-30, 2015 in the amount of \$101,537.14. Don Hatler seconded. Motion approved unanimously.

Beth reported that a 3% statewide cost of living increase went into effect July 1st and that employee retirement contributions increased approximately 1.5%, as well.

Announcements/Public Comment

Matt Heins announced that Dungeness Farms gave the state and Jamestown S'Klallam Tribe approval to do stream channel work in the Dungeness River on their property that is expected to be necessary for upstream salmon migration during this summer's drought and low stream flows.

OLD BUSINESS

WACD Area Director Report

NW Area Director, Don Hatler, reported that a public records requests lawsuit against WACD was settled for \$80,000. Don also reported that a draft resolution has been prepared that would require District elections to be conducted by the County Auditor's office but still conducted in the 1st quarter of the year. This would result in special elections, which would be very expensive. The draft resolution will be discussed at WACD area meetings in October. Don reported on the WACD Executive Committee's recommendation to renew the Executive Director's contract without a performance review and to authorize the hiring of the Executive Director's wife as his assistant. The Board elected to send a letter of No Confidence to the WACD Board President and to share the letter with other districts and the Conservation Commission.

Matt Heins moved to send a letter to WACD Board President, Alan Stromberger, expressing dissatisfaction with WACD. Robert Beebe seconded. Motion approved unanimously.

NEW BUSINESS

Washington State Conservation Commission Master Contract Approval (item added at meeting)

Matt Heins moved to approve the Washington State Conservation Commission Master Contract. Robert

Beebe seconded. Motion approved unanimously.

Cost-share Rate Approval

Don Hatler moved to approve existing cost-share rates. Matt Heins seconded. Motion approved unanimously.

Washington Conservation Society membership

Joe Holtrop reported that the District has been asked to join the Washington Conservation Society. Board consensus was to not join the Washington Conservation Society.

Cooperator & Cost-Share Agreements

Matt Heins moved to approve a Cooperator Agreement with V. Jackson and D. Royall. Don Hatler seconded. Motion approved unanimously.
