APPROVAL OF MINUTES

Matt Heins moved to approve the minutes from the November 8, 2016 regular board meeting. Robert Beebe seconded. Motion approved unanimously.

REPORTS

Staff Reports

Meghan Adamire conducted site visits to two cattle farms to assist with farm planning, attended planning meetings for potential projects partnering with the Forest Service on replacement of pipes draining to the Sitkum River on the 2900 Road, and worked on planning for several CREP projects next year. Jennifer Bond reported that the Clark and Legacy septic repairs are moving forward, weather permitting. Jen attended the Dungeness Shoreline Landowner's meeting and stated that the Jamestown S'Klallam Tribe is willing to pay for a workshop to educate professionals and other interested parties on soft shoreline options. Board consensus was that the District should be at the table, but not the lead. Jen also attended a Streamkeeper's meeting on PIC trends sampling.

Joe Holtrop reported that the Dungeness Irrigation District McComb Rd. to Levee piping project is out to bid and that the bid opening will be December 15th. Joe also reported that design work continues with the Sequim-Prairie-Tri Irrigation Association piping of their independent ditches. The aquifer recharge proposal submitted to Graysmarsh has received verbal approval. The aquifer recharge project northwest of Robin Hill Farm Park is going forward but, due to landowner concerns about well water contamination, we will maintain a 100-foot radius protected area around each well. This will reduce infiltration capacity, but the engineer thinks it will still be adequate.

NRCS Report

Jim Poffel reported that there is a lot of interest in high tunnel houses and that there were 8 EQIP sign-ups in Clallam County. Jim also reported that Washington NRCS received 100% of the budget requested and are planning to be hire 42 new employees statewide.
